**The topicality of research** is proved, first of all by the fact that in the Russian Federation process of formation of public authorities still continues. It is connected with the radical restructurings which have begun in the 90th years of the last century and proceeding until now. The state looks for ways of creation of effectively functioning government of management. It should be noted that this process proceeds not only at the federal level, but also on regional. For the last 20 years the institute of the head of the subject of the Russian Federation has passed a long and difficult way of formation and development. In this regard, special relevance is acquired by the maintenance of the corresponding legal regulation of the status and activity of the highest officials of territorial subjects of the Russian Federation.
